



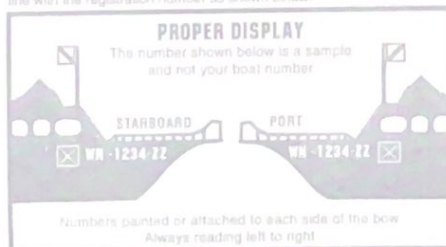

- Apply to clean, smooth, wax-free surface at moderate temperature.
 - Peel decal from paper backing by bending backward at center and lifting edge.
 - Position decal and rub firmly to surface.

PLACEMENT OF DECAL ON BOAT
 Decals must be placed on both sides of the bow, aft of and directly on line with the registration number as shown below.



REGISTRATION NUMBER
 The registration number must be firmly placed on both sides of the bow in block letters not less than three inches in height in a color distinctively contrasting with the background. The number must read from left to right and included spaces of hyphens the width of the letters (other than 'I') between the three parts of the registration number. The decals must be placed on both sides of the bow, aft of and directly on line with the registration number as shown at left.

DOCUMENTED VESSELS
 Affix decals to the forward half of the vessel on each side of the bow. Do not display WN registration numbers on documented vessels.
